

685 WALL BASE ADHESIVE

DESCRIPTION

Healthy Home 685 Wall Base Adhesive is a solvent free, non-flammable, freeze-thaw stable, acrylic latex-based adhesive specifically designed for the installation of vinyl, TS rubber, thermoplastic rubber, or carpet wall base. This adhesive is designed for use over almost any porous, clean, dry, and structurally sound wall. Healthy Home Adhesives 685 Wall Base Adhesive can be applied directly to the wall base or directly to the wall.

NOTE: Not recommended over non-porous walls including vinyl wall coverings. Installing over a non-porous substrate will not allow the adhesive to properly dry.

Shelf Life

Unopened packaging stored in proper conditions have a shelf life of 2 years.

INSTALLATION INSTRUCTIONS

All subfloor preparation instructions from the flooring manufacturer and current industry standards must be followed. Spread Adhesive either on the wall or the surface of the wall base using a 1/8" square notch trowel. Ensure a proper gap is left at the top of the wall base that will allow the adhesive to cover the very top of the base, but not "ooze" from the top of the base. Any adhesive that gets on the wall will need to be cleaned using a clean rag and water when wet or use Mineral Spirits when dried. Follow acclimation instructions for the wall base material. Most require 24-48 hours of acclimation before installation. This prevents the wall base from expanding or contracting after installation.

CLEAN UP

Fresh adhesive can be cleaned up using water and a clean cloth, dried adhesive will require the use of mineral spirits or other clear solvent.





FIRST AID MEASURES
